1. Approval of minutes – the minutes were approved as posted.
2. Discuss Progress on Bike Skills Path - John O'Connor was supposed to come talk to us but he hasn't yet. He is involved with Friends of Missoula Parks. We will table this discussion until John O'Connor can be here. Jane will offer him an invite for the next meeting.
3. Discuss Sign for Bellevue Park - Deadline for the large grant has come and gone (Oct 25) so this will be a project for next year.
4. Plan a Meeting with Park Dept. - Work was stopped on the Bellevue Park irrigation project by Chris Boza because of an issue with the pump. Now Mr. Boza would like us to get the trees planted ASAP but we do not have water. Hans proposes we set up a meeting with all the parties to figure out how and when to move forward with this project. On a side note, there are piles of dirt dumped at the park. Jane will contact Donna Gaukler to find out who and why.
5. Assign Leadership Team Duties/Roles - Deke Tidwell has opted to resign as leadership team secretary. He will remain as a leadership member at large until further notice. All other duties have been assigned via sign-up sheet.
6. Community Forum Report – Bob Martin - Mark Thane presented and said bond expenditures are at or below budget. Projects should be complete by 2018. Barry Fischer- Planner for Fox Theater site- (Riverfront Triangle). They want to start construction in 2017 and it will take 3-6 years. There was an informative presentation for the library bond. They are shooting for a 100 year life-span.
7. Office of Neighborhoods Report – Jane Kelly, Neighborhood Coordinator - Community forum is a week early on November 17 because of Thanksgiving this

month. November 15 invitation to MCAT for holiday greeting. Show up a little before 5:30 with your bells and Santa hat. December CF meeting will be Dec 15. Will be a brief meeting followed by a Holiday Party.
